I encourage the business community to attend as many of these events as possible. Get out there and learn what is going on in your community and share your comments to help make De Soto better!





Unified School District No. 232 leads Johnson County in graduation rates

The Kansas State Department of Education measures graduation rates for every school district. This information is released annually on each district's report card. The most recent graduation rates are included for USD #23 Valley, Olathe, Shawnee Mission, Gardner-Edgerton, and Spring Hill.

Blue Valley	96.1 %
Gardner Edgerton	92.2 %
Shawnee Mission	92.1 %

Five -Year Adjusted Cohort Graduation Rate

The fiveyear cohort graduation rate is the percentage of students in a cohort, adjusted for transfers into or out of school, district, or state, who graduate with a regular high school diploma within five years of entering high school. A student who graduates during his/her fifth year of high school will not be counted as a graduate in the cohort graduation rate, but will count as a graduate in the five year rate.

The fiveyear cohort graduation rate formula for 2015 is:

2015 graduates (# of cohort members earning a regular HS diploma by September 30, 2015)

of first-time 9th graders in fall 2010 plus transfers in minus students who transfer out, emigrate, or die during 2010, 2011, 2012, 2013, 2014, 2015

Three seniors named Finalists for National Merit Scholarships
Top 1 percent of all high school seniors

The National Merit Scholarship Corporation named three high school seniors in USD 232 as Finalists in National Merit Scholarship Program. Jaycie Thamer of De Soto High School, Justin Curto and Allison Kubiak of Mill Valley High School are among the 15,000 Finalists in the prestigious scholarship program, placing them among the top one percent of all high school seniors in the country. These academically talented high school seniors have an opportunity to compete for some 7,400 National Merit Scholarships worth more than \$32 million that will be awarded in the spring.

About 1.5 million juniors in more than 22,000 high schools entered the 2016 National Merit Scholarship Program by taking the 2014 Preliminary SAT/National Merit Scholarship Qualifying Test, which served as an initial selection program entrants. The nationwide pool includes the highest scoring entrants in each state. The number of Finalists in a state is proportional to the state's population.

To become a Finalist, the student and his/her high school must submit a detailed scholarship application, including information on the student's academic record, leadership abilities, employment, and honors and awards received. A Semifinalist must demonstrate outstanding academic record throughout high school, be endorsed and recommended by a high school teacher or administrator, and have demonstrated leadership abilities, employment, and honors and awards received. A Semifinalist must also have a minimum 3.5 GPA and be a member of a school organization or community activity.

Steps in the 2016 Competition

All National Merit Scholarship winners will be selected from the group of Finalists. Merit Scholarship designees are selected on the basis of their skills, accomplishments, and potential for success in rigorous college studies, without regard to gender, race, ethnic origin, or religious preference.

National Merit Scholarships

Three types of National Merit Scholarships will be offered in the spring of 2016. Every Finalist will compete for a National Merit® \$2500 Scholarship that will be awarded on a state representative basis. About 1,000 corporate-sponsored Merit Scholarship awards will be provided by approximately 250 corporations and business organizations for Finalists who meet their specified criteria, such as child-rearing, community service, and other criteria. In addition, about 190 colleges and universities are expected to finance some 3,900 college-sponsored Merit Scholarship awards for Finalists who will attend the sponsor institution. National Merit Scholarship winners of 2016 will be announced in nationwide news releases beginning in April and concluding in July. These scholarship recipients will join more than 100 other distinguished young people who have earned the Merit Scholarship title.
